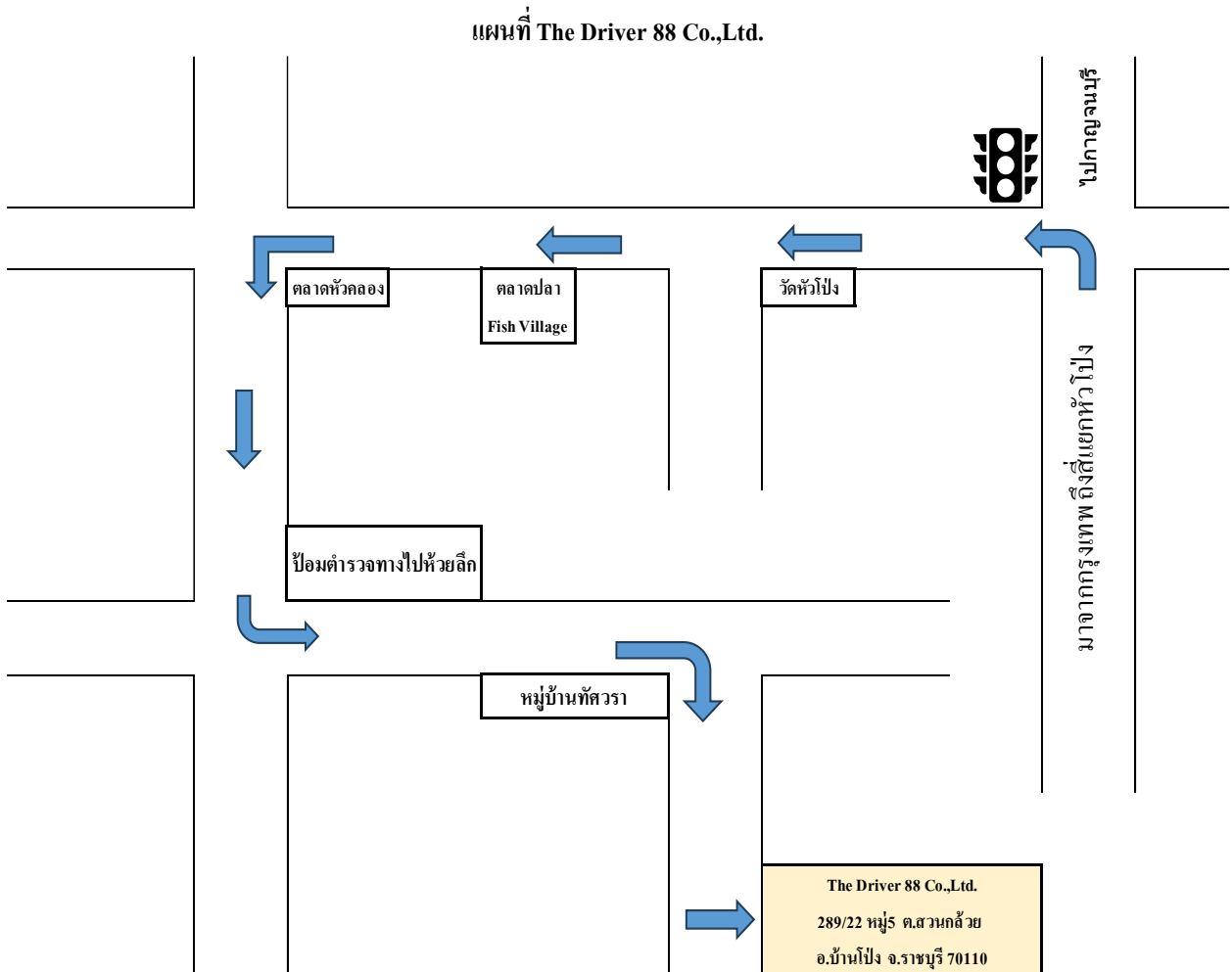

Remark:

1. Any cancellation must be made with a minimum of 2 days' prior notice. Otherwise, the company reserves the right to charge 100% of the car service.
2. Additional fees apply for pick-up or drop-off outside Asoke-Sukhumvit area or the airport (approximately 30km). For Amata Nakhon Industries (80km, 1.5 hours' drive), Rayong Industries (180 km, 2.5 hours' drive) inquire at the office for specific charges elsewhere.
3. In the event that a passenger chooses to stay in the vehicle over than 10 minutes, a Start Engine Fee of 300 Baht per hour will be applied. Example # If work 20 Mins (300 B./ 60 Mins = 5 B) ,20 mins * 5 B = 100 B
4. If a vehicle is used in a province and an overnight stay is necessary, there will be a charge of 600 Baht per night. (Prices may be adjusted on public holidays).
5. Every hour after midnight and before 5 am is considered as night fee hours (200 Baht per hour)
6. In the event that the vehicle is used for less than 30 km./ day, the company will charge for a minimum of 30 km.
7. Overtime allowance (a fraction of 15 minutes is counted as half an hour a fraction of 45 minutes is counted as 1 hour)
8. In the event of war or unavoidable natural disasters, and to accommodate fluctuating circumstances, it may be necessary to adjust the prices quoted in the pricelist. The company will notify you in advance of the work date.
